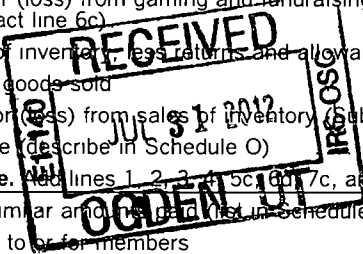

The Santa Clarita Track Club promotes running sports for the youth of Santa Clarita Valley.
